IRS Determination Date*

Your IRS determination letter must be dated prior to March 2020. Fiscally sponsored organizations cannot be funded due to Federal Guidelines.

To qualify, your organization must provide programs and/or services specifically designed to support older adults (aged 55+). This means your programs/services are specifically designed to reach and positively impact seniors. Seniors cannot just be one of the demographics of your program.

COVID-19 Impact*

To qualify for funding, your nonprofit must have been financially impacted by the COVID-19 pandemic in at least one of the following three ways:

- Your cost of providing services increased because you had an increase in demand for your senior services/programs (more seniors were requesting your services than prior to 2020)
- Your cost of providing services increased because your operational or programming cost increased, such as a raise in rent, increase in salaries, hiring of more people, etc.

And/Or

- You experienced a decrease in funding either because of a decrease in donations, contracts, sponsorships, special event revenue, etc.

If you are approved for funding, the Community Foundation of Snohomish County will work with you to determine the dollar amount for each of the COVID-19 impacts that affected you by using your Form 990s and/or financial reports. These amounts will help determine the grant amount but as grants will not be more than \$50,000, the grants will likely not cover these total increased costs or total losses.
